That said, explosive detection dogs have proved to be very reliable in efforts to curb crime. Explosive canine dogs compliment other explosive detection capabilities such as explosive particulate; and explosive vapour.

Explosives detection dogs may also be used to detect explosives in the environment through:

- screening of cargo and mail;
- screening of hold baggage; and
- as a complementary method to improve explosives detection for:
 - aircraft search;
 - vehicles search;
 - screening of airport- and in-flight supplies;
 - screening of persons and screening of cabin baggage.

I believe that such details and the various best practices across the globe are to be shared in this two day training and I look forward to seeing implementation of better practices.

Uganda looks forward to continued cooperation with ECAC and AFCAC in relation to Aviation security.

I implore the various delegates from different countries to take time off the busy schedule and visit some of the tourist attractions in Uganda.
