Ladies and Gentlemen, in view of all the above, lam confident that all these Government plans will go a long way in developing the air transport industry and to contribute to the social, political, and economic prosperity of our Great Nation Uganda.

It is projected that by 2033, air traffic will have grown to a tune of 10 million international passengers per annum. I would therefore like to implore the Board and Management of the Uganda Civil Aviation Authority (UCAA) and all other airport players to observe with strictness the minimum required standards of ICAO to strive to deliver reliable, efficient, and quality air transport services.

The Government of Uganda is highly committed and will continue to support and provide an enabling environment for the growth of the Aviation industry in the country to spur economic development.

To our development partners, let me use this opportunity to express my deepest appreciation to the Republic of South Korea and its development agency the Korean International Cooperation Agency (KOICA) for working assiduously towards supporting the Government of Uganda to improve Airport Efficiency, Airport Safety and the Human Capacity Building through training and the customized technology transfer. This is a

demonstration of the mutual and beneficial relationship that exists between our Governments and people of Uganda and KOICA.
