The Board is focused and fully committed to delivering the mandate as clearly stipulated in the instruments of appointment. I warmly welcome the new members on board. Together, we shall ensure maintainance of the highest standards of safety, security and service in civil aviation.

Hon. Minister, as a way of briefly reflecting on some of the successes registered in the previous term, we are pleased that the Authority managed to improve the level of effective implementation of International Safety Standards, and upgrade of aeronautical infrastructure, among others.

One of the major highlights of the last three years was steering the Authority through the tough times of COVID-19 that adversely impacted aviation operations across the globe. This would not have been possible without the cooperation and support from you, and the entire Top Management Team from the Ministry of Works and Transport.

Uganda's aviation industry is now well on the path to recovery. The August 2023 international passenger traffic figures attest to this. In August 2023, Entebbe International Airport recorded a total of 191,507 international passengers, an average of 6,177 passengers per day, the highest passenger traffic to be recorded in a single month in the history of the airport's While projections by the International Civil operations. Aviation Organisation (ICAO) previously indicated that African countries were expected to fully recover from the pandemic in terms of passenger traffic performance by the end of 2024, Uganda may attain the feat a little earlier, judging from recent trends, an indicator of good performance, which needs to be sustained through attraction of more operators to Uganda's airspace. We shall do our best to build on these to take the aviation industry forward.
